

RoHS I, II, & III Compliance Declaration

S4J Manufacturing Services, Inc., a supplier of components that could potentially be used in products targeted for RoHS compliance, recognizes our responsibility to assist you, our customers, in meeting your environmental policies and procedures.

The European Union set forth Directive 2011/65/EU (RoHS II), effective 3 January 2013, (and superseding RoHS I 2002/95/EC) with the objective of establishing restrictions on the use of hazardous substances in EEE (electrical and electronic equipment) for the purpose of contributing to the protection of human health and the environment. Annex II of this Directive (as amended by RoHS III Directive (EU) 2015/863) lists the restricted substances and the maximum concentration values tolerated by weight in homogeneous materials as:

S4J collects and maintains material certification/test results for our raw materials.

In the manufacture of our **electroless nickel plated brass components**, S4J machines product from brass rod which contains lead as a percentage of weight above the 0.1% threshold but below the 4% lead by weight allowable under the **exemption** given in Annex III of the Directive: **6(c) "Copper alloy containing up to 4% lead by weight."** For products that include a lock washer and panel nut, the lock washer is 410 stainless steel and the panel nut is nickel plated brass. S4J products otherwise do not contain RoHS restricted substances per the above definition. To this end, S4J Manufacturing Services, Inc. manufactures components **in compliance with the RoHS Directive 2011/65/EU and Directive (EU) 2015/863.**

S4J manufactures **all other components** from raw materials that **do not contain banned or restricted substances**, and therefore are **in compliance with Directive 2011/65/EU and Directive (EU) 2015/863.**
